# HISTORY OF PROGRAM

The original idea came from Don Linssen, a commissioner at the time, who attended a meeting with some representatives of Martin County. Martin County had its own internship program designed to match students with local employers. Linssen liked the idea, and told Bruce Heitkamp, Nobles County Administrator, that Martin County is on to something good.

Heitkamp reintroduced the idea of an internship program, and in 2023 the county partnered with the Southwest Minnesota Private Industry Council to launch its own program.

Fifteen interns participated the first year by interning at local businesses for the summer. This opportunity is available for college students from Nobles County, whether they are traditional or non-traditional students. They can be paid up to \$17 an hour, depending on the position, and can work a maximum of 29 hours per week.

After a successful first summer, the Nobles County Commissioners voted to continue the program for another year.

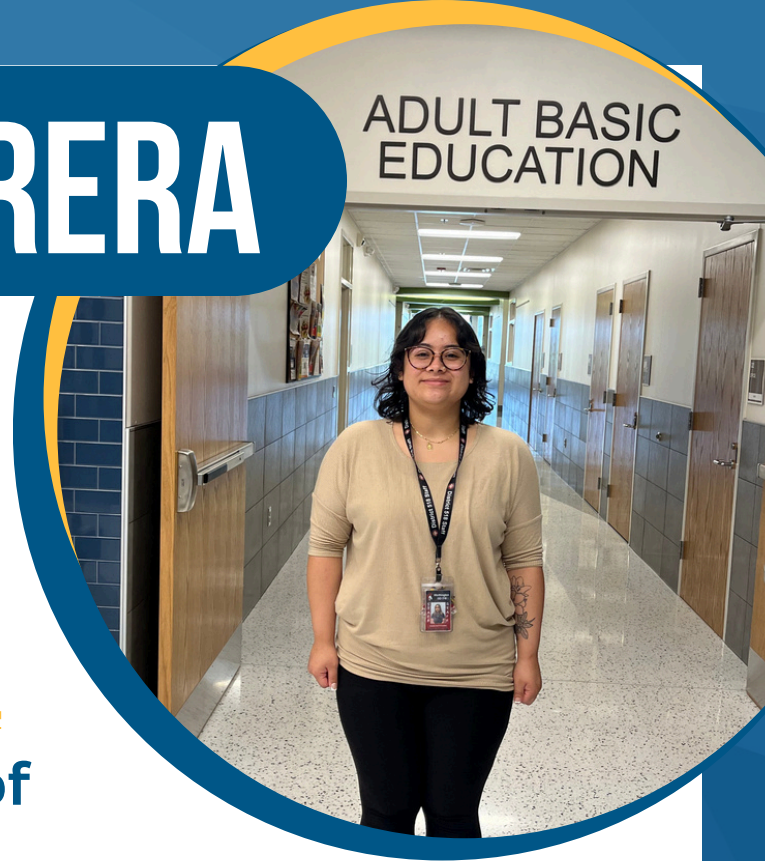

## What is your favorite part of your internship?

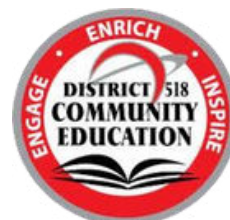
